

STAMBAUGH TOWNSHIP BOARD

Regular Meeting

The meeting of the Stambaugh Township Board was called to order by Supervisor Isaacson on March 9, 2022, at 7:00 pm at the Stambaugh Township Hall.

The Pledge of Allegiance was said.

Roll call was taken with Supervisor Isaacson, Clerk Christensen, Treasurer Rogers, and Trustees Pangrazzi and Stolberg present. Also present was Water Supervisor, Gary Pangrazzi.

The minutes were read from the February 9, 2022, meeting and accepted as read.

Clerk Christensen read the bills for the month and a motion was made by Treasurer Rogers to approve the bills with a second by Trustee Pangrazzi. Bills were approved.

Treasurer Rogers read the Treasurer's report which was accepted as presented.

The County is applying for a grant to make improvements at the Pentoga Park boat launch with the support of Stambaugh Township.

Mike Stafford is inquiring if the Township is willing to share our GIS mapping data. The County is willing to pay \$1500 for two years for this information. Treasurer Rogers made a motion for the Township to share the GIS mapping data. Trustee Stolberg seconded the motion. Motion carried.

The Chicaugon Lake Homeowner's Association has informed us via a letter that the milfoil issues in the lake are continuing. They have been working on controlling it by chemically treating the milfoil and manually pulling it out to remove it. They are looking for monetary support to continue this process. Supervisor Isaacson made a motion to donate \$5,000 to the Association. Trustee Pangrazzi seconded it. Motion carried.

Supervisor Pangrazzi reported that the pump test was completed on the new well. A water test sample has been sent to Whitewater Associates. Construction can continue after the water test has been approved.

Wyatt Johnson will be starting in our Water Department on April 1, 2022. Supervisor Isaacson will inform Tom Marcell that his position will be eliminated.

Road projects for 2022—University Road will have work done with more gravel and culverts for \$149,867. West Brule Lake Road will have some blacktop overlaying done for \$111,195 and Osterlund Road's last section will be overlayed as well for a little over \$109,000.

Board of Review will be at the hall on March 14th and 15th. Treasurer Rogers made a motion to approve a resolution to allow appeals from property owners in writing to the BOR. Trustee Pangrazzi seconded the motion. Motion carried.

Treasurer Rogers proposed a resolution to change the winter tax due date back to February 14th. Treasurer Rogers made a motion to do so with a second from Supervisor Isaacson. Motion carried.

The WID Library has notified us that it is Stambaugh Township's turn to have a rotating member on their Library Board. Patti Sabotta has expressed interest for this four year position. Treasurer Rogers made a motion to have Patti Sabotta assume this responsibility with a second from Trustee Pangrazzi. Motion carried.

Clerk Christensen shared an e-mail from County Clerk Julie Kezerle requesting all of our ballot containers be brought to the Courthouse for inspection by the Board of Canvassers the week of May 9, 2022.

Supervisor Isaacson read the zoning permits.

Our Annual meeting will be March 30, 2022.

Our next regular meeting will be held on April 13, 2022.

Trustee Pangrazzi made a motion to adjourn the meeting with a second by Treasurer Rogers. Adjournment took place 7:38 p.m.
